

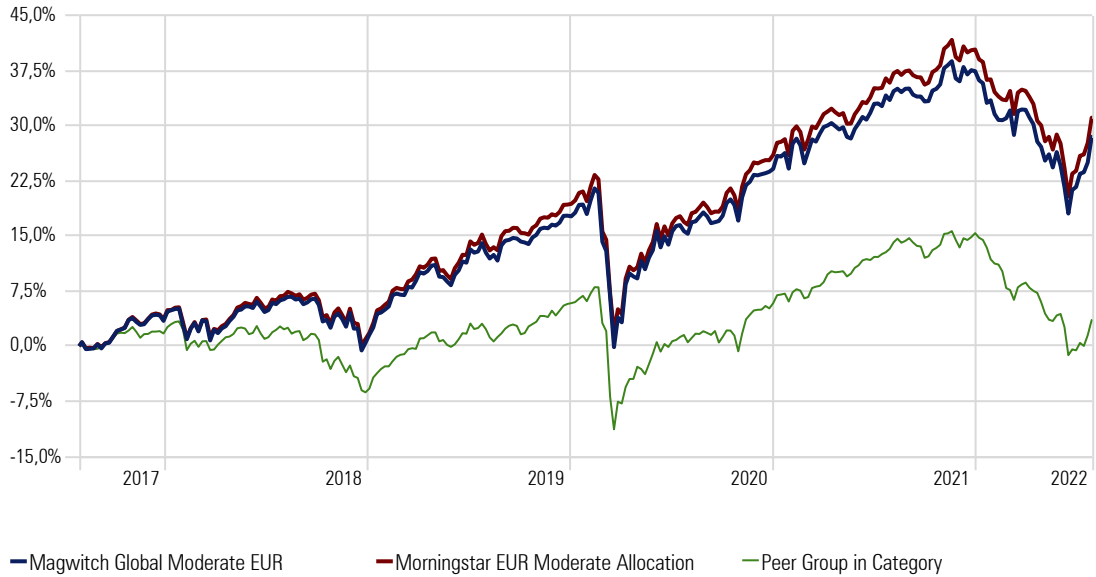
## Investment Strategy

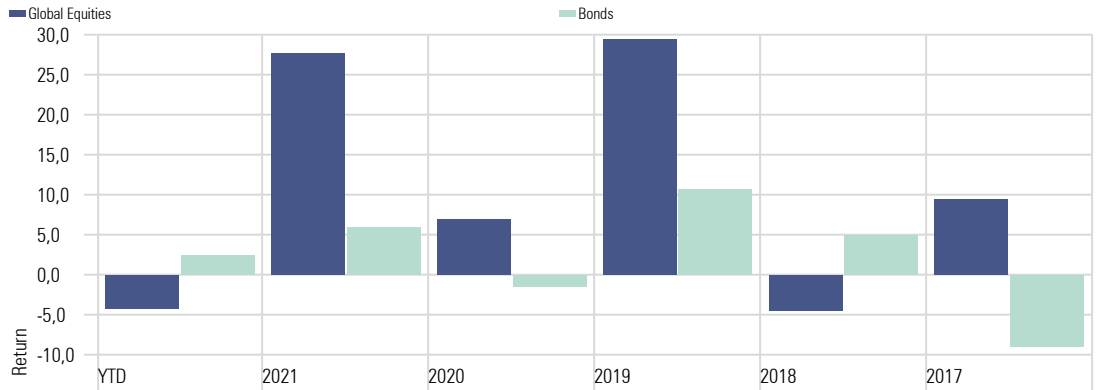

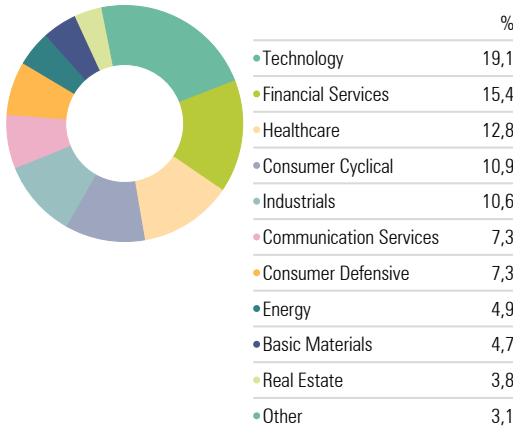

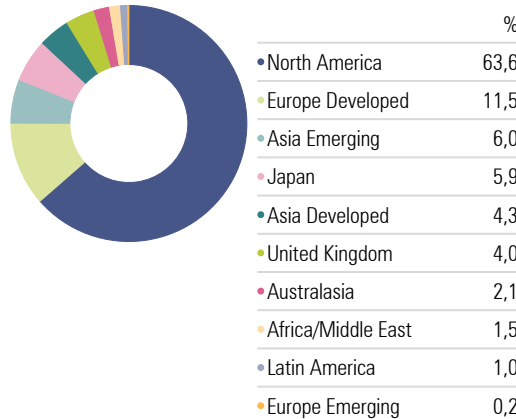
