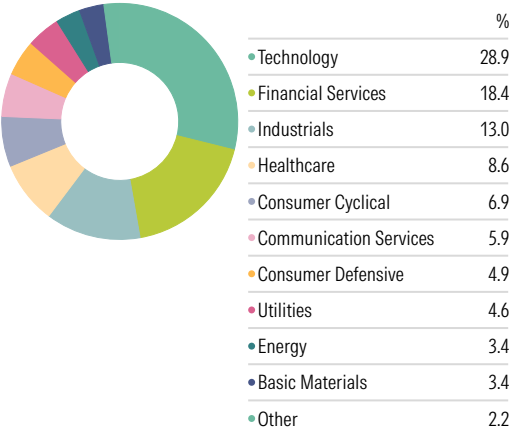

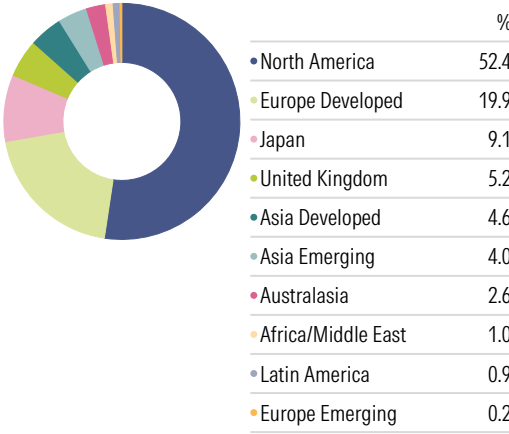

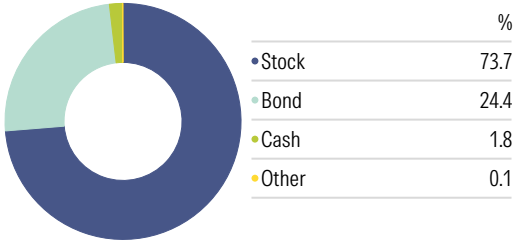
Sector Exposure
